I acknowledge that should any behavioral issues or concerns should arise, that I will seek help from a professional trainer or behaviorist for assistance, lessons or training prior to surrendering back to Guardian Angel Rescue. I agree to make every effort to correct behavior issues with assistance if needed. I agree that should I have to move from my home, I will make every effort to find housing that allows said dog/puppy to live with me. In addition, due to circumstances and only after I have made every attempt to resolve any problems, should I not be able to provide a home for this pet, I agree to contact Guardian Angel Rescue and not surrender to any other person, shelter or rescue.

I agree to spay or neuter the animal if it has not been done prior to adoption. I agree to be diligent with regards to insuring that no breeding will take place should said dog or puppy not be spayed or neutered prior to adoption. Should a litter result from not spaying, Guardian Angel Rescue reserves the right to take possession of the full litter and parent, therefore voiding the adoption agreement. In addition, should the dog/puppy not be micro-chipped, upon his or her first examination or spay/neuter, he/she will be micro-chipped and I will notify Guardian Angel Rescue of the micro-chip number for their records. I understand that Guardian Angel Rescue will not consider the adoption complete until vetting/micro-chipping has been done.

I understand that under NO circumstance am I allowed to crop the ears or tail of the dog/pup I am adopting.

I understand that under NO circumstance am I allowed to de-claw any cat/kitten I am adopting.

I understand that under NO circumstance am I allowed to train said dog/puppy to become aggressive in any way. (Guard dog, fighter, etc.)

* Dogs and puppies need to be seen by your vet within 30 days of adoption for a wellness visit. There is NO exception to this policy and no special considerations will be given. We will provide all the medical information for the dog/puppy to take to the vet prior to the appointment, but it will be your vet who will determine vaccination updates, micro-chipping costs and medical needs including the appointment time for the spay or neuter if required. Should I cancel my appointment or change my vet for any reason, I will contact Guardian Angel Rescue with this information. I agree that Guardian Angel Rescue can do a follow up in my home after the adoption is complete and give Guardian Angel Rescue permission to follow up with my veterinarian about the care that is being provided.

I agree to hold, Guardian Angel Rescue and all members associated with Guardian Angel Rescue, under no liability for damages, incidences, lawsuits, judgments or any other financial responsibility for the dog or actions taken once ownership is transferred. I agree to take full financial and physical responsibility for this dog. This agreement is a binding legal contract and once signed is fully in effect. A copy of this agreement will be given to you at adoption. Any breach of this contract can result in Guardian Angel Rescue reclaiming ownership of said dog or puppy. I agree to pay all cost necessary to enforce this contract, including all attorney fees and all costs of litigation if contract is breached.

I acknowledge that all information that I have provided is true and honest. I agree that should I provide any false information, this contact is null and void.
